The Promoter

The Promoter is Salesian College, Maynooth Rd, Celbridge, Co Kildare

The Draw

- The draw will be held monthly on the first Friday of each month
- The first draw will take place at 3.30pm on Friday, March 4th, 2022
- One entry to the draw is priced at €10 pm
- Three entries to the draw is priced at €20 pm
- All members who paid their draw entry during the previous calendar month will be included in the draw
- Entries close at midnight on the last date of each month
- €500 will be paid to the winner of the draw each month

Entry Requirements

The Raffle Draw is open to anyone aged 18 or over as at the date of the draw who has purchased a ticket during the previous calendar month. By taking part in this Raffle Draw, the participant is deemed to have read and understood the terms and conditions of this promotion and agrees to be bound by them

How to Enter the Raffle Draw

Entry is by means of an online entry via <https://www.pallasmarketing.ie/product/scc500>
After purchase of an online ticket for the draw participants will receive an email with their raffle ticket number. This number will be the same for all draws. An email does not issue for monthly renewals.

Winner Selection

The winning ticket will be drawn at the school by the Promoter using a computer based random number selector.

Recurring Entry / Cancellation

The entry is a monthly entry and will continue until a participant cancels their payment. Cancellation is done by logging in to <https://www.pallasmarketing.ie/my-account>. Once in, click on “My Subscription” and click on “Cancel”. Participants are asked to send an email to info@pallasmarketing.ie to advise of their cancellation and avoid follow up contact.

General Rules

- The Promoter will not enter into correspondence with third parties and will not use alternative contact details to those supplied upon purchase of the ticket
- If not known to the school, the winner must provide proof of Identity (Passport or Drivers Licence)
- If a winner does not claim the Prize, does not respond within 4 weeks of their details being posted on the website of the Promoter, or is unable to provide valid proof of identity and address verification, such winner waives the right to claim the Prize and the Prize will be awarded to the winner chosen in a second draw.
